Additional Competition Warrantee

This warrantee is an extension of the original warrantee on the Brittany puppy concerned being sold as a *competition prospect*.

This puppy has been evaluated found to be of show quality, and worthy of show competition. It is warranted to be free of disqualifying faults as set by the AKC standard for the breed, and is considered finishable. No warrantee is implied as to the time frame it will take to attain its championship as this is beyond our control.

If the quality of the pup comes into question in the first year written notice must be given to the breeder, and the puppy made available for re-evaluation at that time. If the claims are founded a replacement will be arranged with a pup of suitable quality within a reasonable time frame, (1yr.) upon return of the dog to the breeder. NO replacements will be made after 2 years of age; replacements will be made to the first owner of the dog only. Refunds will not be made in any instance.

The BUYER agrees not to breed this dog until the age of 2 years and at such time it is x-rayed and receives an OFA number certifying it free of hip dysplasia. The BUYER also agrees this dog will NOT be bred to another dog not bearing an OFA number itself. Note: Doing so will be in direct conflict with the American Brittany Club's Code of ethics. No dog harboring ANY other hereditary defect from should ever be bred this includes PRA, Epilepsy, & heart disease. This dog may also not be neutered without the breeders prior notice & consent.

****If the puppy is bought with a pup back arrangement it MUST be from a mutually agreed upon breeding. Pup must be made available to the breeder from the FIRST breeding of the said dog and the ENTIRE litter must be present at the time the choice is made. In this instance we reserve 1st pick dog/bitch as our choice.****

We the BREEDER reserve the right to co-own some show pups IE: in the instance the new owner has not finished a dog before. Once this dog attains its title we sign off sole ownership to the BUYER. This merely protects our interest in the dog attaining its championship as planned for when it is place with the new owner.

****ALL show prospects MUST carry our "TRIUMPHANT" kennel name as a prefix in their AKC registered names. ****

- 2.) ____ Co-Ownership with breeding rights to the above-mentioned dog, to the breeders bitches only. For an indefinite period of time, no re-sale of this animal may be made without the BREEDER/Co-Owners permission & signature.
- 3.) ____ Co-Ownership until such time as this dogs championship is attained. No resale of this dog maybe made without the BREEDER/Co-OWNERS permission & signature.
