This agreement is entered into this _____ day of _____, 2007
between the two parties listed for stud services of the dog listed above.

Terms of agreement

- 1.) Stud fees are payable in full at the time of service unless other arrangements have been made for payment, or if a puppy is to be taken in lieu of the fee by the stud owner.
- 2.) The only guarantee is that of the actual mating. If the bitch fails to whelp a return service will be made to the same dog provided this stud is still in my possession, with a 1 yr limit for return of service. If this stud is not available for any reason I reserve the right to mate this bitch with another of our stud dogs. If the ownership of the bitch changes, rights to return of service will be at the stud owner's option.
- 3.) If a puppy is to be received instead of a cash fee, I will make my choice of the litter at 7 weeks of age. ALL puppies from the litter must be present when I make my choice. The rights to choice of litter are in no way affected by change of ownership of the bitch or stud dog. As the stud owner we reserve 1st. pick dog/bitch as our choice. We also reserve the right to use our own kennel prefix only in naming this pup and are in no way obligated to use the bitch owners. As the stud owner we are solely responsible for any air transportation or shipping fees necessary to get the puppy into our possession.

- 4.) It is agreed the stud owner is under no obligation to sign the AKC paperwork for this litter until the stud fee is paid in full, or the stud puppy is in my possession.
- 5.) Two live pups constitutes a litter, I cancel a puppy choice if no pregnancy occurs either time bred, or there are no living pups at 8 weeks of age.
- 6.) The bitch owner is responsible for all vet fees incurred as a result of getting this bitch bred. IE: A-1 fees, smears, progesterone & L.H. level tests.
- 7.) Transportation of the bitch to and from the stud dog is the responsibility of the bitch owner. Any & all fees incurred in doing so are also the responsibility of the bitch owner.
- 8.) Prior to breeding proof of vaccinations, a negative stool sample and a negative brucellosis test must be provided in writing to the stud owner. Copies of the bitches OFA & any other clearances must also be provided.
- 9.) The bitch owner agrees no pups from this litter will be sold at pet stores or other whole-sale outlets. The owner of the stud dog will refer prospective puppy buyers to the bitch owner. It is however the sole responsibility of the bitch owner to screen these buyers.
- 10.) Stud owner will provide the bitch owner with a photo, and a four-generation pedigree of the stud dog. Copies of the stud dogs health clearances will also be provided.

While in our care your bitch will reside in our home and be hand walked for the duration of her visit. However, we will not be held responsible or liable for accidental death, illness or injury while she is being transported to or from us, or while she is residing here with us.
